Seven years ago a project began to fix the inconsistencies in our numerous governing documents. Thanks to the generosity of Association member, Rob Kinas and his law firm, Snell & Wilmer L.L.P., the home stretch of the journey began in earnest two years ago. The result of these efforts were to consolidate our multiple governing documents into two documents: (i) Amended and Restated Articles of Incorporation and (ii) Amended and Restated Bylaws. Now, the membership has the opportunity to vote on whether to accept these proposed documents or not. Published inside this issue of Inside Tennis is the Notice and Proxy Card. You will notice that there are 3 ways to cast your vote:

- Come to the Annual Meeting on April 16, 2009 at 6:30 pm Pacific time at Snell & Wilmer L.L.P.
- Sign and return the Proxy Card, which is in this issue of Inside Tennis; or
- Vote on-line at www.nevadatennis.usta.com

We have over 4200 members! We must have a quorum with a majority of the quorum voting Yes! to adopt the Amended and Restated Articles and Amended and Restated Bylaws. **That means we need approximately 420 members voting either in person or via proxy with over 50% of those members voting Yes!
